CONDITIONS OF MEMBERSHIP

1. Hoofbeats Incorporated hereafter called the club is an adult riding club dedicated to the advancement of knowledge and the enjoyment of horse ownership. The club has a minimum age for membership, therefore an individual must have attained the age of eighteen years prior to applying to be a member of the club.
2. As a member of the club I am entitled to:
 - a) Attend any or all of the clubs activities and events including the clubs monthly meeting where I am free to submit with notice for consideration any proposal I feel is relevant to the advancement of the club or its activities.
 - b) Receive a monthly newsletter on the clubs activities and upcoming events
 - c) Submit articles for publication in the newsletter I feel are relevant and of interest to the other members of the club.
3. As a member of the club I agree to:
 - a) Abide by all of the conditions of membership.
 - b) Provide help at no less than one Hoofbeats event or scheduled day per year.
4. Membership is for the equine year commencing 1 August and ending 31 July the following year. Renewal of membership is due 1 July each year and payable within 30 days.
5. New Membership is defined as an applicant who has not previously been a member or an applicant who has not been a financial member for a period not less than thirteen months. Membership is for the equine year or part thereof and the amount due is in accordance with the set fee scale defined in paragraph 8 below.
6. Renewal Membership is due and is deemed to have commenced in accordance with paragraph 3 regardless of any delay in payment.
7. Family Membership is afforded to a group of applicants who having attained the specified age for membership share a common family heritage or who are husband and wife or who are currently living as a family.
8. **Fees and subscriptions** The scale of fees & subscriptions are:
 - a) **New single membership**
 - i) Joining fee \$5.00
 - ii) Annual subscription \$40.00
 - b) **Renewal single membership**
 - i) Annual subscription \$40.00
 - c) **New family membership**
 - i) Joining fee \$5.00 each member
 - ii) Annual subscription \$60.00
 - d) **Renewal family membership**
 - i) Annual subscription \$60.00
9. Membership of the club does not entitle me to a share of the assets of the club nor an annual dividend from the profits of the club.
10. The assets of the club are held in perpetuity and administered by the committee of the club for the benefit of members of the club.
11. The profits of the club are held as retained earnings of the club and are administered by the committee of the club for the betterment of the members of the club.
